Noncompliance Certain light duty trucks and sport utility vehicles equipped with automatic transmissions fail to comply with the requirements of Federal Motor Vehicle Safety Standard No. 102, "Transmission Shift Lever Sequence, Starter Interlock, and Transmission Braking Effect." These vehicles could have a shift cable lock plate that is too brittle and can break. The gear shift lever and the "PRNDL" indicator may move, but the transmission will not shift out of the "Park" position. Also, the gear indicated on the display may differ from the gear engaged in the transmission. If the driver selects "Drive" and the transmission is actually in "Reverse", a vehicle crash could occur.

Remedy Dealers will replace the automatic transmission shift cable lock plate. The manufacturer has reported that owner notification began Nov. 6, 2000. Owners who do not receive the free remedy within a reasonable time should contact Nissan at 1-800-647-7261.

Defect On certain sport utility vehicles, the alloy wheels used on these vehicles may not have been properly manufactured and cold develop cracks in the wheel spokes. If a sufficient number of spoke cracks develop, the wheel could fail and separate from the mounting hub, possibly resulting in a vehicle crash without prior warning.

Remedy Dealers will replace the four alloy wheels with Xterra SE model bright alloy wheels. The spare tire steel wheel is not affected. The manufacturer has reported that owner notification began on September 15, 2003. Owners may contact Nissan at 1-800-647-7261.

Defect On certain pickup trucks equipped with six cylinder engines, and sport utility vehicles equipped with four or six cylinder engines, the fuel pump terminal on the fuel-sending unit can develop a crack in the plastic molding. This can cause the terminal strip to corrode under some environmental conditions. If corrosion occurs, the terminal strip could eventually break causing the fuel pump to stop operation. This will result in not being able to start the engine or cause the engine to stop running without warning, which can result in a crash.

Remedy In the following states, dealers will replace the fuel-sending unit. These states are Connecticut, Delaware, Illinois, Indiana, Iowa, Kentucky, Maine, Maryland, Massachusetts, Michigan, Minnesota, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Tennessee, Vermont, Virginia, West Virginia, Wisconsin, and the District of Columbia. If corrosion The Fuel Pump Terminal On is present, the dealer will replace the unit. If there is no corrosion, the dealer will apply sealant to The Sending Unit For the terminal housing to help prevent corrosion in the future. The Autosource database contains inspected dealer inventories, dealer advertisements, phone verified vehicles, and private party advertisements from thousands of sources including automotive publications, newspapers and Web sites. Autosource uses vehicles comparable in year, make and model within the specified market area, expanding as necessary, to determine the loss vehicle's local market value. This valuation includes a representative sample of the vehicles used to calculate the typical starting price.

The market search originated from Zip Code 37323, as determined by the vehicle owner's principally garaged area. Autosource located 41, 2000 Nissan Xterra vehicles which were used to determine the typical vehicle price. Adjustments have been made to the comparable vehicles for value differences in vehicle description as indicated in the "Veh Adj" field. The sum of the 41 comparable vehicles is \$241,315 for an average price of \$5,886.

The asking or actual sale price is displayed for each vehicle. If a vehicle has been sold, the sold price is displayed with an (S) indicator. The selling price may be substantially less than the asking price. In the case of this 2000 Nissan Xterra, the difference between the asking price and selling price is generally 7%. This selling price adjustment has been applied to the typical price. Additional adjustments have been made to the typical vehicle price taking into consideration the loss vehicle's mileage, equipment and condition.
